Executive Summary

AAPA surveyed members of its Environment Committee and researched publicly available reports to compile this repository of environmental and sustainability initiatives and reports at port authorities. The findings include the reports and studies of 46 U.S. port authorities, seven Canadian port authorities, and fifteen Caribbean and Latin American port authorities. The enclosed reports cover topics including air quality, water quality, electrification, combatting climate change, efficient operations and management, and more.

This repository will be a living document, as all Environment Committee members are welcome to add their own port authority's work that is not yet included and update existing documents that may be out of date. The aims of this repository include the following:

Identifying Best Practices: The repository helps identify the most effective strategies and practices implemented by seaports to promote sustainability. By understanding what measures are successful, other ports can learn from these best practices and implement similar initiatives.

Encouraging Collaboration: The repository fosters collaboration among seaports. It allows them to share information, exchange ideas, and collaborate on innovative solutions. By learning from each other's experiences, seaports can collectively work towards reducing their environmental impact.

Policy Development: The repository can inform policy development at local, regional, and national levels. Governments and regulatory bodies can use the data to understand the current practices in the industry, assess the effectiveness of existing policies, and design new regulations that promote sustainable practices in seaports.
